- IV. Co-chair for Student Affairs Report. S. Domenici gave an introduction on the duties of reps, discussed the ARC Center, the new grants program, chartered organizations, and business cards.
- V. Health Services Committee
  - A. Appointment of Celia and Ericka co-chairpersons. Motion to appoint C. Braxton and E. Calton as 2005-2006 committee co-chairs.

- B. Update on referendum status and upcoming activities. C. Braxton gave a brief update on the referendum timeline.

### VI. Old Business

A. Movie Ticket Price (again). T. Lee gave a brief presentation on the current movie ticket price and informed the body that the wholesale price would be going up during the next year. Motion to increase the selling proce of movie tickets purchased from the DSC from \$5.50 to \$6.00 and not increase it again when the wholesale proce increased.

- C. Medical Test Subsidies 70%. Motion to decrease the DSC medical test subsidization from 90% to 70%.

D. Budget Vote. T. Lee led a discussion on various points of the budget, including the Wellness Center and Travel and Research, as well as several other budget lines of interest to individual members. Motion to approve the budget.

## VII. Co-Chair for Communications Report.

- A. Tuition Increase Protests. D. Golland discussed organizing silent protests in May and June to fight the impending tuition increases.
- B. New GC President and Acting Provost (Correspondence, FAS Committee). D. Golland reported on the appointments of President Kelly, Acting Provost Edwards, and Acting Associate Provost Julian Wrigley.
- C. Other FAS Committee items. D. Golland discussed the action of the Board of Trustees Standing Committee on Faculty, Administration, and Staff naming Nathaniel Cruz as Acting Vice President for Student Development and Enrollment Management at Hostos Community College.
  - D. Golland reported that The Advocate was proceeding towards its first edition of the new year and was in need of a designer; Quark proficiency preferred; reported that the website had been updated with a new look including the new DSC logo.

- A. Student Funding Issues. T. Carayannis gave a brief presentation on student funding. There is a \$20,000 cap, which discourages students from seeking large external grants.
- B. Confirm Auxiliary Enterprises Board members. Motion to nominate former Co-Chair for Student Affairs C. Fischer (not present) and C. Lieberman to the Auxiliary Enterprise Corporation Board of Directors for 2005-2006.

Motion to request that the Graduate Council Committee on Committees nominate D. Golland for the Committee on Structure, Chris Poulios for the Committee on Curriculum and Degrees, and A. Levy (not present) for the Committee on Student Services, with the understanding that S. Domenici would serve on the latter committee if A. Levy declined the nomination.

Motion to extend for the 2005-2006 session of the Doctoral Students' Council the endorsement of the position that CUNY ask the Bronx District Attorney's Office to drop all charges against Miguel Malo.
