- EL reminds the Plenary that the sign-up period for Chartered Organization rosters close January 4th, 2010. Some Chartered Organizations are still not active because they need more people to sign their rosters.
- The Fund Raising Committee met and subdivided in to two committees with one focusing on each macro and micro donations. The subcommittees may meet during January.
- The Adjunct Project hiring committee has picked a new coordinator, Stephanie Jones.
- Presentation of Doctoral Theater Students Association constitution by Christopher Silsby, provides history and functions of the group and its constitution.

KM motions to bring the vote on the four chartered orgs that did not pass last meeting back to the table, ADA seconds, motion carries.

Co-Chair for Communications (KL)

- Student affairs will be checking eligibility of DSC representatives at the close of the registration period. To stay eligible for DSC, students need to have passed 50% of the courses they registered for in the previous semester.
- Based on a survey of fall fitness class participants the spring offerings have been changed to include an intermediate yoga class. One more pilates section was also added. Online registration will begin mid-January.
- Student protests are happening in response to the proposed tuition hikes. The Adjunct Project will be doing workshops in the spring that may cover important legal issues like the "Henderson" rules for protests at CUNY.
- There is a lawsuit against the CUNY Boars of Trustees. Ron McGuire is the lawyer in the case. The dispute is about the timing of tuition hikes and the illegally of transferring tuition setting power to the Chancellor.
- NYSHIP
- o Rates have increased by 18% for individuals and 23% for families.
- o Increase in retroactive paycheck deduction max from \$55 to \$100
- A mentoring survey is being developed and will be sent out soon.

Co-Chair for Business (CS)

- CS is keeping track of the budget.
- He is also developing an archive system for website.
- And, he is working with LM to create a NYSHIP provider directory on the DSC webpage for student recommended healthcare providers that accept NYSHIP.

Wellness Center allocation

CS motions to allocate 48,000 and have the DSC Executive Committee study the provision of health and wellness services for students the graduate center. ADA seconds, and the motion carries with 1 abstention.

- The outreach Committee held an event at Queens College and is identifying issues of communication effecting students based outside the GC campus.
- There is an event in the works for students who are based outside the GC campus on the basics of organizing and communication. It will likely be held on the first Friday in February.

• The writing center proposal draft had been completed. The DSC is currently looking into broadening the focus of the proposed center to also include support for statistics and other technical competencies

Officer for Technology & Library (ST)

• The Student Technology Survey is open until February 1st, 2011. An open meeting with IT and students about modifying Citrix is being planned. If students have Citrix usage comments lease get in touch with ST via email.

Announcements

GD presents on OpenCUNY and notes that a new coordinator has been offered a job. He thanks ST for overseeing the hiring process. The OpenCUNY committee has been assembled and is working on terms of participation. These will come to Plenary in a couple months. Also, GD met with GC IT who are very interested in partnering with, or extending the system to students and faculty. OpenCUNY gets about 4,000 unique visits month.
