- 3. Asserts that resolution is not disciplinary or punitive, but rather targeting institutions
- 4. Responsibility to take stance also based on \$3B support US gives to Israel per year
- 5. Palestinian scholarships, etc. rescinded, not equal or fairly administered
- 6. Recognition of dignity of Palestinian people
- 7. Endorsement of Boycott does not mean dialogue stops, uses Sarah Schulman as example
  - a. Choose when, where, how to engage in dialogue that has consequences in civil rights and international law
- ii. Robert Bell, MES
  - 1. Stresses nature of BDS not to stifle debate
    - Target institutions of Israeli society that impacts oppression of Palestinians
- iii. Balthazar Becker, English, cedes time to
- iv. Nirit Ben-Ari,
  - a. Poli sci alum.
  - b. Has been to Israel, worked at Hebrew University
  - c. Lots of Israelis who support BDS, supports Palestinan call
  - d. Adds that criticism that is levied at BDS supporters as anti-semitism is erroneous. Criticism is part of democracy and democratic societies
  - e. Those who oppose Israel's activities in West Bank should endorse this—a basic act of democracy that is nonviolent
  - f. Those who stand in solidarity and nonviolence will do so by supporting resolution

- g. Best/most moral act students can take to support movement
- 2. Hamad Sindhi cedes time to Tahir Butt, UED.
  - a. Speaks from art history student letter provided by Gwen Shaw from one of her constituents "it is important to clarify that the endorsement is not a blacklist... does not attempt to foreclose...
- 3. Velina Manolova, English
  - a. Considers reason we (DSC reps, students, etc.) are in getting involved
  - b. Those who can stop this are at the federal executive level, but in order to make then feel any sort of motivation or pressure they need to feel pressure from taxpayers and constituents by us
  - c. Issues at CUNY associated with BDS movements are being isolated and discriminated against
  - d. Spying on Muslim student associations, other acts of intimidation
- 4. Colin Ashley, SOC
  - a. Reiterates why this is an academic issue: boycotting issues and structures
    - i. Real lives and people's voices → power is unequal
    - ii. This inequity impacts lives and voices, parity and ability for some to speak over others
    - iii. Israeli institutions and their bias silences Palestinian students
    - iv. BDS evens the playing field—stands up for those who are not stood up for
    - v. It behooves us here at the GC not to stifle conversation, act punitively but we need to stand up to say that people who need to speak
- 5. Sean Kennedy
  - a. DSC takes courageous votes and stands over controversial issues
  - b. DSC as important body for dialogue so that solutions can be reached

- 6. Eric Wallenberg, Hist
  - a. In light of historic votes by DSC
  - b. Recognize BDS has origins in Anti-Apartheid movement
  - c. What is happening in Israel reflects
    Apartheid—suggests we need to use that term
  - d. Wants to see DSC stand on right side of history
  - e. Desmond Tutu also supports BDS
  - f. Wants to see DSC and those who are unsure to think that this is a way to challenge the system of apartheid, here in the us, to impact the funding the US gives to enable these conditions
  - g. Cites firing of professor at Univ Ill at Urbana Champaign—lost job for standing up for Palestinians who lost home
- b. Oppose BDS Resolution
  - i. Anick Boyd, Complit
    - 1. Cedes time to Asaf Shamis, alum poli sci
    - 2. Asaf Shamis, alum poli sci
    - 3. Thanks everyone
    - 4. Suggests that those in favor put this in terms of pro or anti Palestinian or Israeli
    - 5. Real issue: academic freedom
    - 6. Restriction of knowledge based on nationality
    - 7. Don't restrict people based on nationality
  - ii. Erin McKinney Prupis
    - 1. Jewish student in Public Health



- 2. Astonished by BDS
- 3. Cites inventions and work done by Israeli academics and doctors
  - a. E.g. Kinder and gentler
    - i. Measures newborns without discomfort
  - b. Israeli institutions protect and support Palestinians
  - c. Palestinians Al-Quds university
  - d. 60 ongoing joint research projects with Israel
  - e. Resolution made her feel targeted as a Jew
  - f. feels it is anti-Semitism
  - g. Not okay to target Israel and not other nations who have human rights violations
  - h. BDS will not help achieve peace
  - i. Pushes Israel and Palestinian students apart
  - j. As a Jew feels discriminated against

#### iii. Yuval Abrams,

- 1. Dual citizenship student, studied in Israel
- 2. BDS makes him feel that he is not welcome here as an Israeli, he and his colleagues are made to feel not welcome and "beyond the pale."
- 3. Doesn't foster discussion
- 4. Sympathizes that Palestinian students have their rights violated
- 5. Why target Israeli institutions—don't have anything to do with that sort of oppression
- 6. Israeli Univs are powerful engines for social change and civil rights movements
  - a. Hebrew Univ issued claim to get out of the West Bank
  - b. Isr Acad force for good and action
- 7. Had Arab colleagues, professors, guests in Israel
- 8. Asks whether restricting movement is the right way—asking/calling for new ways to give voice to those without voices (i.e. Palestinians)
- 9. Calls out CUNY partnership with Israeli Univ, use that to expand dialogue rather than cut it off entirely

#### iv. Cosim Sayid,

- 1. Shocked to receive resolution
- 2. There are other problems at CUNY—late pay, etc.—but is irritated that academic freedom is on the chopping block with BDS

rather than other important work we have to do

- 3. Suggests that there should be a petition
  - a. BDS Res jumps petitions and other democratic means in order to "go to the DSC"
  - b. "Is the job of the DSC to pick which countries are kosher and which ones are not?"
  - c. Animal rights advocates and children's rights advocates, can also just avoid political discussion by going to the DSC
  - d. Consider what will happen? Thinks that passing this resolution would ruin the DSC's relationship with the new President, Chancellor, and Board of Trustees
  - e. Cites Noam Chomsky—BDS doubly victimizes: not going to do anything for Palestinians and we are having a dialogue about boycott rather than a dialogue about helping Palestinians
