III. Executive Committee Reports

A. Co-Chair for Student Affairs (Silvia Rivera Alfaro)

Updates:

CC-Meeting for Science students' situation with Joshua Brumberg (Dean for Sciences), Zoe Hu (PSC), Arielle Shanok (Director of the Wellness Center), Matt Schoengood (Office of Student Affairs).

Discussion:

JH: Room reservation exceptions aren't in the Bylaws, so technically, we can still "review" it and the CCSA can approve it.

SRA: CompLit also requested the room at the same time, before LAILAC, by email

JH: LAILAC requested it even before, with a grant request for those dates, so LAILAC still requested first

SRA: LAILAC is approved, and we can find a room for CompLit based on number of people and if they need food

JH: We can work with them to fund food out of the Executive Discretion Budget in addition to what they would spend.

B. Co-Chair for Communications (Christopher Campbell)

Updates:

- Sent out election nomination emails
- Sent out surplus request for proposals
 - Students from programs, departments, and student-focused organizations
 - \$100k allocated this year to be allocated next fiscal year, \$15k max per proposal
 - Proposals are meant to be student body wide, aiming to benefit the student body as a whole rather than one program
 - There will be a committee to read over proposals and to allocate funds
 - We will try to give all valid proposals at least some funds
 - I will need help for outreach. I have a two-page PDF that can be sent out. I'll send it to the EOs, APOs, Plenary, anywhere it can be sent out.
 - I've been working with Parisa, who wants to bring a few ideas to the Plenary to see if the Plenary can supplement a stipend for the Childcare Center
 - We can hold an RFP writing workshop in late March / early April

Discussion:

SRA: Some students have more ability for writing proposals, but we are all PhD students. This is part of our professional skill set. The Childcare Center is something people can apply for funding for. Students can make a proposal for GC housing. We can do a public event where people can be informed about the surplus (in the Dining Commons) as an information session where people can have a conversation with someone from administration to answer specific questions about where the funds can or cannot go.

CC: Still the idea would be to do a workshop on writing the proposals.

SRA: Yes that would be nice to do.

JH: It is important to think of the use of money in terms of also not doing the work of the administration. We can't pay for things the admin doesn't want to - that's not what SAF is for.

CC: I will follow with Sayantika on the idea of organizing events.

JH: We have to take care of the committee who makes the decisions to not have bias into some programs.

CC: Thanks for the ideas everyone.

C. Co-Chair for Business (Jonathan Hanon)

Graduate Education

Strengthen CUNY's MA and PhD program offerings as a way to increase affordability and access to graduate-level education. This includes hiring 75 new faculty members and investing in the development of an online education platform to host courses. The University will also invest additional funds for doctoral stipends to remain competitive nationally by ensuring our PhD graduate-level students are compensated to meet their living and academic-related expenses while they complete their studies.

FY2024:

The one paragraph of graduate education is now a page. See page 11.

Now, the reason for prioritization might be because of their goodness of heart, or because of our emphasize on payment in the recent past, and that they decided they should do something about it. Regardless, we should keep on communicating things that are important to the students, and maybe we can help with the effort of budget request by organizing our own trip to Albany for conferences, USS do that every year in winter for multiple conferences. We can directly talk to the law makers ourselves. For example, this year CUNY asked for \$10 million just for improving graduate student compensation (we might not get it, last year we didn't). I have reached out to USS fiscal affairs person, Jonathan Colon, to ask about the cost of the trips.

It may be worth it to use our reserve to organize next year's trip to Albany.

We may also want to talk to people in the Institutional Advancement department to get some context on how funding for graduate student works.

Also as a side note for use of the reserve money, what about a bi-weekly or monthly happy hour at GC? So people can feel they are more involved and better community.
